What is an electronic certificate and two-factor authentication? Electronic certificate – this means an electronic attestation (certificate) which links signature-verification data to a person and confirms the identity of that person. Two-factor authentication - this is a login that requires a second layer of security such as extra information (e.g. shared secret) or a physical device (e.g. bank card, key, card reader), in addition to a password. Digital Identity - Digital Identity is information that is used to identify a person. These services are often provided by governments or other third parties. Digital Identities are sometimes restricted by location or residency status.
